## **POLICY** FOR THE

## 20<sup>TH</sup> HOLE TOWNHOMES ASSOCIATION, Ltd. REGARDING OWNERS OF RENTAL UNITS AND TENANTS RESPONSIBILITIES

SUBJECT:

Adoption of a procedure to ensure that all members of the Association

enjoy the full privileges of residing in our community.

**PURPOSE:** 

Adopt a procedure to ensure the rights of Owners to rent their unit Lot and

the rights of other Owners with respect to that rental

**AUTHORITY:** 

The Declaration and Bylaws of the Association grants the general power

to conduct the business and affairs of the Association.

**EFFECTIVE** 

October 15, 2008

DATE:

RESOLUTION: The Association hereby adopts the following policy and procedures:

Owners shall have the right to lease such Owner's Lot subject to the following conditions:

(1) Owners may not lease less than such Owner's entire Lot

(2) all leases shall be in writing for a term of not less than six (6) months

(3) all leases shall provide that the terms of the lease and the tenant's occupancy of the Lot shall be subject in all respects to the provisions of the Declaration, the Articles of Incorporation and By-laws of the Association, as well as any rules and regulations promulgated by the Association; and

(4) no lease may be for transient or hotel purposes.

Owners shall notify the tenants that they are renting in a community association, and in addition to any requirements in the lease, they must abide by the governing documents, rules and regulations of the Association.

Owners shall provide the tenants with copies of the governing documents, rules and regulation of the Association and require a signed acknowledgement by the tenants verifying that they have received the material and agree to abide with them. The tenants should acknowledge that if they fail to comply with terms of the Declaration, the Articles of Incorporation, Bylaws and any rules and regulation of the Association that the Owners may be fined for the actions of the tenants.

Owners shall provide a copy of the lease, the name(s) of the tenants and the signed acknowledgment by the tenants verifying that they have received the Association's documents to the Association Secretary within ten (10) days after execution of the lease.

The Association has no authority to either enforce rules or to levy fines directly on tenants. Therefore, in the event the tenants fail to comply with the Association's governing documents, rules and regulations, the Association will continue to deal with the Owners who remain members of the community. If the Owners do not respond to the Association's notice of tenant's violation, the Association shall follow their enforcement policy.
