(Notes from last meeting: A request from a neighboring home to the property 14596 E Wagon Trail Pl to share the cost of replacing the fence was discussed. Other requests similar to this have been presented in past years and the answer remains that these fences are not the responsibility of the association. They do not sit on association land per the original plats.)
