To all residents and future residents:

DESIGN REVIEW PROCESS

The Carriage Homes at Stapleton Association's mission is to promote the long term value, and harmony between the residents for the greater good of the neighborhood. To enable the Association to succeed in their mission, there are Guidelines, Rules and Regulations of the Associations, which must be followed by all residents of the neighborhood. The Design Review Process is a very important component of the Association's missions.

The Design Review Process includes:

- 1. The resident or future resident to obtain a Design Review application from the Association's Management Company.
- 2. The resident or future resident to complete the Design Review application, include all necessary documents, such as plans, materials, photos, drawings, paint color swatches, etc. and forward the application and materials to the Association manager.
- 3. The Association's Management Company stamps the date the application was received, reviews the application for completeness and then forwards the complete application to the Design Review Committee.
- 4. The Design Review Committee reviews the application and then approves or denies the application.
- 5. The Association's Management Company will forward the decision back to the resident.
- 6. If approval by the Master Community Association at Stapleton's Residential Renovation and Remodeling Design Review Committee is deemed necessary, the resident will be required to submit a plan to the Master Community Association at Stapleton's Residential Renovation and Remodeling Design Review Committee as well.

Frequently Asked Question regarding the Design Review Process:

- May I perform this architectural improvement to my home? *Please obtain an answer by contacting your Association's Management Company or by submitting a design review request form.*
- Will I need to obtain the Design Review Committee's approval to perform this architectural improvement to my home? Please review the Design Review Submittal Form or obtain an answer by submitting a design review request form or contacting your Association's Management Company.
- How long does the Design Review Process take? The Design Review Process could take up to 45 days, so please plan accordingly.
- What happens if I construct or install an improvement to my home and I fail to go through the Design Review Process, when necessary? The Association will require you to submit an application after-the-fact. In doing so, the Association has a record of

the improvement and the Design Review Committee's decision. If the Design Review Committee does not accept the improvement, the Association may ask you to retro your efforts to meet the required guidelines or remove the improvement at your expense.
