- The replacement of lighting fixtures throughout the community was discussed.
  Owners asked the Board to consider setting a new standard for fixtures to be replaced.
- Issues of security were raised related to the vehicles on the property and suspicious individuals seen lingering.
- There were question regarding how aggressive is the Board and management with respect to collections of delinquent accounts.
